#### Processing of personal data in Moramast AB

When you use our website or in other ways are in contact with us, for instance by the purchase of our products, Moramast AB will process your personal data. Below you will find information regarding which type of personal data that is being collected, the reasons for and purposes of why we collect the data and your rights regarding the processing of your personal data.

# 1 The purposes of our data collection and what types of data we collect

We collect and process your personal data for various purposes depending on who you are and how we get in touch with you. We collect the following personal data for the purposes mentioned below:

- 1. Sending out marketing materials, such as newsletters and information regarding our activities: The processing of data is based on your given consent, or commercial interest of sending you information we believe you would find valuable.
- 2. Respond to incoming enquiries: Name, telephone number, e-mail address and other personal data collected in connection with the enquiry. The processing purpose is based on the legitimate commercial interest of helping you with your enquiry.



- 3. The recruitment of new vacancies and positions: CV, applications references and attestations. The processing of data is based on your given consent.
- 4. Our website uses cookies, and even if none of them save personal information it is important to know. You can also choose which cookies you allow us to set on your computer. You can read more about cookies and which cookies we use here: <a href="https://moramast.se/integritetspolicy/">https://moramast.se/integritetspolicy/</a>. The processing of cookies is based on your given consent. For example we use the information for statistical purposes. In this statistics it is not possible to identify you as an individual. We delete collected user and event data in 26 months after last activity by the user, and session cookies last no more than 30 minutes.

#### 2 Disclosure of personal data to others

We do not give out or disclose your personal data to others, unless there is a legal obligation for such disclosure. Examples as to basis for disclosure could typically be a contract with you or legal basis in the law instructing us to provide out the information.

Moramast AB uses data processors to collect, store or in other way process data on our behalf. In such cases we have concluded data processing agreements to ensure the information security in all segments of the data processing. As of today we use the following data processors:

1. Saferoad ASA. Moramast AB is part of the Saferoad Group. Personal data is being processed for the purpose of handling orders and deliverer services to our customers. The processing of personal data is being carried out in the computer systems of the Saferoad Group.

All processing of personal data carried out by us is done within the EU / EEA area.

#### 3 Storage period

We only store your personal data for as long as necessary for the purpose the data was collected for.

This means for instance that personal data collection based on your consent will be deleted if you withdraw your consent. Personal data we process in the performance of a contract with you will be deleted when the contract is implemented and all obligations pursuant to the contract have been implemented.



## 4 Your rights when we process your personal data

You have the right to obtain access to, correct and delete your personal data processed by us. You also have the right to obtain restriction of processing, direct objection to the processing and obtain the right to data portability.
